**ORDINANCE #2018-35C**

**AN ORDINANCE AMENDING Chapter 145, "Pickleball Courts, Municipal," of the "Code of the Borough of Beach Haven, County of Ocean, State of New Jersey" to establish fees**

**WHEREAS**, the governing body wishes to increase the fee for a daily pass, create a weekly pass and establish a fee for a group lesson.

**NOW THEREFORE, THE MAYOR AND COUNCIL OF THE BOROUGH OF BEACH HAVEN DO HEREBY ORDAIN:**

**SECTION I**

Chapter 145-2, "Fees for passes," of the Code of the Borough of Beach Haven, shall be amended as follows (underscores represent additions; ~~strikethroughs~~ represent deletions):

A. Passes for the purposes stated in § 145-1 hereby will be issued by the Borough Clerk or his or her designee in accordance with the following fee schedule:

(1) Daily pass: ~~\$2~~ \$3 per person.

(2) Weekly pass: \$10 per person.

(3) Season pass: \$45 ~~\$50~~ per person.

B. Passes are required beginning the Saturday of Memorial Day weekend through Labor Day, annually, or when an attendant is present.

C. No fees shall be charged to or collected from any persons who have served in any of the Armed Forces of the United States and who were discharged or released therefrom under conditions other than dishonorable and who either have served at least 90 days in active duty or have been discharged or released from active duty by reason of a service-incurred injury or disability upon presentation of acceptable proof of discharge to the Borough Clerk or other Borough employee responsible for collecting the fee.

D. Lessons:

A fee of \$5.00 shall be charged for participation in a group lesson by an attendant. The lesson fee shall include rental of a Beach Haven paddle and a daily pass for the day of the lesson.

**SECTION II**

All Ordinances or parts of Ordinances inconsistent herewith are repealed to the extent of such inconsistency. The Borough Clerk is authorized to renumber and/or re-codify any sections affected by such repeal to the extent consistent with this Ordinance.

**SECTION III**

If any word, phrase, clause, section or provision of this Ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal or unconstitutional such word, phrase, clause, section or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.

**SECTION IV**

This Ordinance shall take effect upon publication thereof after final passage according to law.


