ORDINANCE #2018-37C

AN ORDINANCE AMENDING Chapter 199, "Vehicles and Traffic," of the Borough Code of the Borough of Beach Haven, County of Ocean, State of New Jersey, 2000" in order to regulate parking for electric vehicles.

WHEREAS, the establish fees for parking of electric vehicles.

NOW THEREFORE, THE GOVERNING BODY OF THE BOROUGH OF BEACH HAVEN DOES HEREBY ORDAIN AS FOLLOWS:

SECTION I

Chapter 199-54 of the Borough Code is hereby amended as follows (strikethroughs represent deletions; underline represents additions):

199-54, CHARGING STATION FEES

The following fees shall apply to use of parking spaces within the Borough of Beach Haven identified as "charging station spaces," as that term is defined in Section 199-52 of this chapter:

- a. ~~For up to one (1) hour of charging, one dollar and fifty cents (\$1.50).~~
- b. For ~~more than~~ up to one (1) hour and up to two (2) hours of charging, three dollars (\$3.00) per hour.
- c. ~~For more than two (2) hours and up to three (3) of charging, five dollars and fifty cents (\$5.50).~~
- d. For ~~more than~~ up to three (3) hours and ~~up to four (4) hours of or more of charging, eight dollars (\$8.00)~~ six dollars, (\$6.00) per hour.

SECTION II

All ordinances, or parts of ordinances, inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

SECTION III

If any word, phrase, clause, section, or provision of this ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal, or unconstitutional, such word, phrase, clause, section, or provision shall be severable from the balance of the ordinance and the remainder of the ordinance shall remain in full force and effect.

SECTION IV

This ordinance shall take effect upon publication thereof after final passage according to law.
