ORDINANCE #2025-8C

AN ORDINANCE AMENDING Chapter 95, "Fire Prevention", Article XIIA Knox Boxes, of in the Borough Code of the Borough of Beach Haven, County of Ocean, State of New Jersey

PURPOSE

The purpose of this ordinance to clarify when a Knox Box is required for commercial and non-residential properties.

NOW THEREFORE, THE MAYOR AND COUNCIL OF THE BOROUGH OF BEACH HAVEN DO ORDAIN:

SECTION I

95-88.3 "Knox Boxes required for existing commercial buildings." shall be amended as follows (<u>underscores</u> represent additions; strikethroughs represent deletions):

§ 95-88.3. Knox-Boxes required for existing commercial <u>and non-residential</u> buildings.

All commercial <u>and non-residential</u> buildings in existence at the time of the adoption of this article which are equipped with automatic fire detection and/or suppression systems shall have installed a Knox-Box[®], of a UL type and size approved by the Borough Fire Official, in a location specified and approved by the Borough Fire Official within 12 months of the effective date of this article.

SECTION II

All Ordinances or parts of Ordinances inconsistent herewith are repealed to the extent of such inconsistency. The Clerk of the Borough is authorized to renumber and/or re-codify any sections affected by such repeal to the extent consistent with this Ordinance.

SECTION III

If any word, phrase, clause, sections, or provision of this Ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal, or unconstitutional, such word, phrase, clause, section, or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.

SECTION IV

This Ordinance shall take effect upon publication thereof after final passage according to law.
