#### **NEW BUSINESS/PUBLIC HEARING**

- 1. **Murray Bulk Variance** bulk variance to permit second curb cut for second driveway where only one curb cut per lot frontage is permitted, resulting in loss of 2 on-street parking spaces, for property located at 215 Marine Street (Block 118, Lot 15)
- 2. D'Agostino Bulk Variance bulk variance to permit a front yard setback that is less than the required 15 feet; 12.5 feet to the proposed new front deck and 8.4 feet to the proposed new front stairs and to allow 0 off-street parking spaces, where the requirement is a minimum of 2 off-street spaces is required, for property located at 425 5<sup>th</sup> St (B164, L1.04 & 1.01)
- 3. Review/Adoption of the Beach Haven Municipal Public Access Plan (MPAP) an amendment to the Master Plan, it ensures the state-required public access at existing access points and allows the Borough to maintain eligibility for ongoing beach maintenance permits
