#2025-21C AN ORDINANCE repealing and replacing Chapter 212-28.1, "Placement of small cell equipment and telecommunications facilities," of the "Borough Code of the Borough of Beach Haven, County of Ocean, State of New Jersey, 2000"

PURPOSE. The governing body finds that it is in the best interest of the Borough to repeal and replace Chapter 212-28.1 to provide a more efficient process for review and approval of small cell equipment and facilities, while ensuring maximum Borough control and influence over the placement and aesthetic design of small cell facilities to minimize the visual impact on the community but maximize the quality of wireless service available to Borough residents and visitors.

#2025-22C AN ORDINANCE AMENDING Chapter 212, "Zoning," of the Borough Code of the Borough of Beach Haven, County of Ocean, State of New Jersey, 2000" reorganizing Sections 212-8 through 212-17, incorporating provisions related to Historic Preservation into Chapter 212, and defining certain processes for the Business District.

PURPOSE. This Ordinance is intended to reorganize and streamline the Zoning Code of the Borough making it more user-friendly. The Ordinance adopts a chart organizing area, yard and building setback requirements for each district in one location. The Ordinance incorporates zoning-related provisions of the Historic Preservation Chapter into the Zoning Code for consistency purposes and clarifies processes related to the Business District and residential units.
