

ORDINANCE #2024-09

**CAPITAL ORDINANCE OF THE BOROUGH OF
BEACH HAVEN, IN THE COUNTY OF OCEAN, STATE
OF NEW JERSEY, AUTHORIZING SEWER SYSTEM
IMPROVEMENTS BY AND FOR THE BOROUGH, AND
APPROPRIATING THEREFOR THE SUM OF \$375,000
FROM THE SEWER CAPITAL FUND BALANCE OF
THE BOROUGH**

BE IT ORDAINED by the Borough Council of the Borough of Beach Haven, in the County of Ocean, New Jersey as follows:

SECTION ONE: The Borough of Beach Haven, in the County of Ocean, State of New Jersey (the “Borough”) is hereby authorized to make the following public improvements and acquisitions in, by and for the Borough through the Borough’s Sewer Utility Fund Balance, including all work, materials and appurtenances necessary and suitable therefore as follows:

Projects	Estimated Project Cost
(i) Sewer Main and Lateral Replacements - Stratford Avenue (Bay to Oceanfront) and Main Relining – Dock Road (Delaware to Pennsylvania Avenue)	\$375,000
TOTAL:	\$375,000

SECTION TWO: The aggregate sum of \$375,000 is hereby appropriated from the Sewer Capital Fund Balance of the Borough to the payment of the costs of the improvements and acquisitions authorized and described in **SECTION ONE** hereof.

SECTION THREE: Said improvements and acquisitions are lawful capital improvements of the Borough having a period of usefulness of at least five (5) years. Said improvements and acquisitions shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefitted.

SECTION FOUR: The sewer capital budget of the Borough is hereby amended to conform with the provisions of this sewer capital ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended sewer capital budget and capital program as approved by the Director of the Local Government Services, is on file with the Borough Clerk and is available there for public inspection.

SECTION FIVE: This sewer capital ordinance shall take effect after final passage and publication as required by law.
