**TO ALL CANDIDATES FOR THE NOVEMBER 5, 2024

- Petitions must be signed by not less than twenty-five (25) valid registered voters of the Borough of Beach Haven.
- Each petition signer must not sign more certificates for candidates for than there are vacancies to be filled.
- Both the candidate for office and his/her campaign manager must sign separate oaths as to the validity of the signatures on the voter certificates of nomination. These oaths must be returned with the petition.
- Petition circulators must sign an affidavit of New Jersey voter eligibility.
- Completed petitions must be delivered to the Municipal Clerk’s office by 4:00 p.m. on Thursday, August 22, 2024.
- Requests for a designation or grouping of candidates shall also be filed with the Municipal Clerk by 4:00 p.m. on Thursday, August 22, 2024.
- All candidates must comply with the New Jersey Campaign Contributions and Expenditures Reporting Act. Please call (609) 292-8700 to obtain the booklet of information and forms.
