**ORDINANCE #2024-25C**

**AN ORDINANCE SUPPLEMENTING Chapter 35, "Salaries and Compensation," of the Borough Code of the Borough of Beach Haven, County of Ocean, State of New Jersey, 2000,"**

*Purpose: to require full-time and part-time employees to be paid through direct deposit pursuant to N.J.S.A. 52:14-15f.*

**NOW THEREFORE, THE MAYOR AND COUNCIL OF THE BOROUGH OF BEACH HAVEN DO ORDAIN:**

**SECTION I.**

Chapter 35, "Salaries and Compensation," shall be supplemented by the addition of the following:

**§ 35-2. Mandatory Direct Deposit.**

A. All full-time or part-time Borough employees shall be paid only by direct deposit in conformance with N.J.S.A. 52:14-15f.

B. Temporary seasonal employees may be exempted from this policy at the discretion of the Chief Financial Officer as administratively necessary taking cost and other factors into consideration.

C. Pursuant to N.J.S.A. 52:14-15f, all information concerning net pay, any accompanying information approved for distribution with net pay such as a pay stubs, and W-2 forms in accordance with applicable federal laws, shall be made available to all employees only on the internet via restricted access accounts provided by the Borough or an authorized third-party

**SECTION II**

All Ordinances or parts of Ordinances inconsistent herewith are repealed to the extent of such inconsistency. The Clerk of the Borough is authorized to renumber and/or re-codify any sections affected by such repeal to the extent consistent with this Ordinance.

**SECTION III**

If any word, phrase, clause, sections, or provision of this Ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal, or unconstitutional, such word, phrase, clause, section, or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.

**SECTION IV**

This Ordinance shall take effect upon publication thereof after final passage according to law. Any permit issued prior to the effective date of this Ordinance shall not be subject to the restriction on pool construction and installation provided by Section I, hereof.


